A meeting of the Arizona Board of Behavioral Health Examiners was called to order on December 9, 2022 at 9:12 a.m. with Ms. Dobratz presiding.

Ms. Zavala summarized the Board's investigation.

The complainant appeared telephonically and addressed the Board.

The professional's attorney, Mandi Karvis, appeared and addressed the Board.

Following discussion, Mr. Davis moved, seconded by Mr. Shen, to accept the proposed signed non-disciplinary consent agenda. The motion passed unanimously.

The Board took a break at 9:45 a.m., reconvening its public meeting at 9:53 a.m.

5. Administrative Hearings

A. 2021-0025, Gary Tupper, LMFT-15134

Ms. Dobratz moved, seconded by Ms. Kramer to go into executive session pursuant to A.R.S. § 38-431.03(A)(3) to obtain legal advice. The motion passed unanimously and the Board went into executive session at 10:05 am, reconvening its public meeting at 10:25 am.

Ms. Mona Baskin, A.A.G., appeared on behalf of the state.

The professional and his attorney, Dennis Wilenchik, appeared and addressed the Board.

Ms. Carrie Smith, A.A.G., appeared to provide independent legal advice to the Board.

Discussion was held on the professional's Motion for Rehearing and Stay of Order of Revocation. The Board discussed that in the Motion, the professional sought rehearing on the Board's November 10, 2022 Findings of Fact, Conclusions of Law, and Order for Revocation and its obligations under A.R.S. 41-1092.09.

In considering the merits of the Motion, the Board discussed that its November 10, 2022 Order was entered under its statutory authority [A.R.S. 41-1092.08(B)] to modify the administrative law judge's Decision entered October 11, 2022.

The Board discussed the due process afforded to the professional, and the materials it had reviewed:

- the Board discussed that it had reviewed the briefing submitted on this matter, along with the complete underlying file;
- the Board acknowledged that it had listened to the audio from the administrative hearing, below; and
- the Board acknowledged that the professional had been afforded a fair and impartial hearing, and received adequate notice and due process.

The Board discussed that it was permitted to modify the administrative law judge 's October 11, 2022 Decision, as it had done at its November meeting:

- the Board discussed that it had not "rubber stamped" the administrative law judge 's October 11, 2022 Decision as suggested by the professional;
- the Board acknowledged that it had held a thoughtful discussion at the November Board meeting regarding the factual and legal bases for its modification of the administrative law judge's Decision, which resulted in the Board's November 10, 2022 Order; and
- the Board noted that A.R.S. 41-1092.08(B) expressly permitted the Board to "modify" the administrative law judge 's October 11, 2022 Decision.

As to the standard of proof applied, the Board discussed that it had properly modified the administrative law judge's Decision to note in its November 10, 2022 Order that the findings of fact set forth in the Order were reached applying a clear and convincing standard:

- the Board Chair reminded the Board that the clear and convincing evidence standard is familiar to the Board because it is applied in most disciplinary matters;
- the Board discussed that it had asked the professional and his legal counsel at the November meeting whether they disagreed with any fact, as set forth in the proposed findings of fact;
- the Board noted that, after discussion at the November meeting, the professional's counsel agreed that the professional did not disagree with any fact set forth in the administrative law judge's October 11, 2022 Decision; and
- after review of the briefing, the Board maintained that the findings rose to the level of clear and convincing evidence.

The Board also considered additional arguments raised by the professional's counsel, including the following:

- the Board discussed that its previous consideration of the professional's conduct, including matters occurring outside of a therapy context, was not inappropriate or unusual, given that the statute governing unprofessional conduct broadly applies to situations occurring both inside and outside the therapeutic setting; and
- the Board acknowledged that the safety of the public is central to its responsibility, and plays an important role in the Board's decision to revoke licenses, where, as here, the Board determines that the licensee cannot be rehabilitated.

Following review and discussion by members, Ms. Kramer moved, seconded by Ms. Coonrod, to deny the professional's Motion for Rehearing and to affirm the Order for Revocation as previously approved. The motion passed unanimously.

A.A.G. Smith advised the Board that the record could be corrected via Nunc Pro Tunc Order correcting the citations. Ms. Pellitier provided a statement on behalf of the professional, and A.A.G. Baskin provided a statement as well. In response to a question from a Board member, Ms. Pellitier agreed that the requested change was non-substantive and she did not object to the correction.
